

# PROM GUEST CONTRACT FOR NON-ETHS STUDENTS

THIS CONTRACT MUST BE TURNED IN AT THE SAME TIME THAT THE TICKET IS PURCHASED

El Toro students will not be allowed to ADD/CHANGE guests after his/her paperwork has been submitted.

All guests must be no older than 20 years of age. Middle school students are not allowed to attend. All students wishing to attend the dance with a non-El Toro High School guest must fill out and submit this form and abide by the following set of criterion. **Guests pay the non-ASB price. Deadline to purchase tickets is 3:30p.m. on Friday, April 19th. No tickets will be sold at the door.**

**ALL GUESTS MUST ATTACH A PHOTOCOPY OF THE GUEST'S SCHOOL PICTURE ID OR VALID DRIVER'S LICENSE IF NO LONGER ATTENDING HIGH SCHOOL. THE PHOTO ID MUST VERIFY THE GRADE/AGE OF THE GUEST.**

**All contracts must have the SIGNATURE and BUSINESS CARD of the administrator from the guest's high school.**

## ADMITTANCE

- Admittance/attendance is subject to ETHS Administration approval and guests High School Administration.
- **Entrance will be denied unless GUESTS enter the dance at the same time as the ETHS student listed on this permission slip unless prior written approval was given by Mrs. McNeal.**
- **ALL ATTENDEES MUST PRESENT VALID PICTURE IDENTIFICATION AT THE REGISTRATION TABLE AT THE DANCE TO BE ADMITTED. NO STUDENT ID CARD OR VALID ID (FOR GUESTS) = NO ENTRANCE!**
- **NO STUDENT/ATTENDEE WILL BE ADMITTED AFTER 8:30pm AND STUDENTS MAY NOT LEAVE UNTIL 9:00pm** unless prior written arrangements have been approved with the Director of Student Activities, Mrs. McNeal.
- Formal attire is required for Prom. Suggested attire includes formal dresses, suits, or tuxedos. No jeans, shorts, pajamas or t-shirts allowed at the dance. Students must wear shoes at all times. Violations may result in non-admittance. If dress code violations occur after admittance, student/attendee may be removed from the dance. If any attendee has a question about the appropriateness of their dress, please consult with an Administrator prior to the event.

## RULES

1. All school rules and regulations are in force during any school event.
2. All students and their guests may be searched by security for illegal or controlled substances prior to entry of the dance area. Any student that refuses to be checked will be denied entry. **STUDENTS REMOVED/DENIED ENTRY WILL NOT BE GIVEN REFUNDS.**
3. **All attendees may be subject to a random alcohol screening test given by ETHS Administration.** In addition, any student or guest showing observable signs of using alcohol or any controlled or illegal substance will be subject to an alcohol screening test and removed from the dance by Administration. The OC Sheriff's Dept. & parents will be notified. (*Education Code 48900(c) & 48900(s) prohibits the use/possession of alcohol, intoxicants and controlled substances at school, on the way to/from school or at any school related activity*)
4. **Students who purchase tickets are required to inform their guests of all contract rules.** Guests are required to abide by all school rules and the terms of this contract. Any student or guest exhibiting disruptive behavior will be ejected along with their escort. The El Toro High School student will be held accountable for the behavior of their guest.
5. Forgery of any part of this behavior contract will lead to non-attendance to the dance and disciplinary actions as determined by the school administration.

## CONDUCT

1. No inappropriate dancing (deemed by ETHS Administration) such as freaking, moshing, or slamming will be permitted. As of 01/11/06, the following Freak Dancing guidelines have been put into effect in all 4 SVUSD High Schools: **1.) NO BENDING OVER, 2.) KEEP BOTH FEET ON THE GROUND, 3.) NO RIDING LEGS, 4.) NO FRONT TO BACK DANCING.** **NOTE:** Violation of the dancing policy will consist of immediate removal from the dance and the assignment of a Saturday school. No reimbursement or refund will be given when asked to leave the dance for not following the agreement.
2. Students who violate any school rule or the terms of this contract at the Dance will be suspended according to district and school policy.

**DO NOT BRING ANY OF THE FOLLOWING TO A DANCE:** Gels, liquids, aerosols, lanyards, perfume, gum, food, mints, lipstick, chapstick, chargers/portable chargers, pens, pencils, markers/highlighters or backpacks. Leave these items in the car or limo. These items will be confiscated at the dance and ETHS is not responsible for confiscated items.
