IX.a. District English Learner Advisory Committee (DELAC) Report - presented by Faviola Marquina

Minutes:

The former secretary of the District English Learner Advisory Committee (DELAC), Faviola Marquina, provided a report. She stated that it is the responsibility of the DELAC to annually advise the SVUSD Board about the following legal requirements: EL District Master Plan, District needs assessment for parents of English Learners, establishment of District program goals and objectives for programs and services for English Learners, development of a plan to ensure compliance with any applicable teacher and instructional aide requirements, review and comment on the new assessment for English proficiency, review and comment on District's reclassification procedures, review and comment on the written notifications required to be sent to parents and guardians, and training and consultation.

It was reported that the number of English Learners continues to grow, and the DELAC appreciates the network of support that the District has built for parents of English learners through the Family Resource Center. Ms. Marquina thanked the District for ensuring that English Learners receive a quality education.

IX.b. California School Dashboard Local Indicators Progress Report - presented by Laura Ott, Assistant Superintendent, Educational Services and Cathy Kane, District Coordinator, Assessment and Accountability

Minutes:

Cathy Kane, District Coordinator for Assessment and Accountability provided a video report regarding the California School Dashboard Local Indicators Progress Report. Performance and progress are reported through State and Local Indicators. Local Indicators will be reported for the first time in the

Dashboard in Fall 2017. Districts measure and report their progress based on locally collected data using State created standards and the State Board of Education approved self-reflection tools. Districts report progress on Local Indicators to the governing Board during a regularly scheduled Board meeting and to the public through the CA School Dashboard following the meeting.

IX.c. PTA Council Report - presented by Terri Parnell, President

Minutes:

Terri Parnell, SVPTA President, reported that the last Saddleback Valley PTA meeting of the year was held on November 15, 2017. Saddleback Valley PTA was honored to be one of the sponsors for the SVUSD Career Fair. Food and volunteers to help staff the event were provided. On October 30, 2017, Carla Taylor and a team of volunteers collected and processed the Reflections entries. The entries were judged last week and some of the entries will be sent to the Fourth District PTA to be judged with other Orange County entries. SVPTA will be hosting a Reflections Art Gallery Night in March for the students, parents and community.

IX.d. Coastline Regional Occupational Program (CROP) Report - presented by Amanda Morrell, CROP Representative

Minutes:

Trustee Morrell reported that the Coastline ROP Board of Trustees met on Thursday, October 12, 2017.

As a part of the California Apprenticeship Initiative grant, Coastline ROP began an Automotive Pre-apprenticeship Internship class at Laguna Hills High School. Patrick Sullivan, and one of his former students, Matt Feist, shared a presentation on the program. Matt spoke about his apprenticeship experience and the positive impact it continues to have on him as he continues his education and begins a career in the automotive industry.

Ray Shanahan, EMT instructor at THHS, shared that one of his El Toro High School students, Kevin Frum, successfully passed the EMT National Registry exam and is now employed by Care Ambulance Service.

The Mission Viejo High School Crime Scene Investigation class and the Laguna Hills High School Administration of Justice class joined together to hear Sgt. Rob Roggeveen of the Riverside County Sheriff's Department share his experiences in the Los Angeles High-Intensity Drug Trafficking Area Domestic Highway Enforcement Strategy program. Students were intrigued to hear about the effects illegal drugs are having on our society as well as some of the drug seizures his team had performed. Many law enforcement career questions were asked by the students.

Darin Petzold's Manufacturing Engineering Technology class visited the

HAAS facility in Oxnard and about thirty students from Trabuco Hills High Schools visited Orange Coast College for Manufacturing Day.
