Students: Parking permits **will not** be issued if you do not have the above information completed **and** a copy of your CA driver's license attached. MVHS will not make a copy of your license for you. You must provide your own copy.

1. Parking permits are available to Seniors and Juniors ONLY with at least a **2.0 Academic GPA**. **Parking permits will be issued on a "first come first served" basis.** Parking permits are only good for **the school year in which it was purchased.**
2. Parking permits are NON-Refundable and NON-transferrable.
3. A parking permit **DOES NOT** guarantee a parking space, it only grants the right to park on our campus.
4. Permits will be sold at the MVHS Student Store. You must have a current valid CA driver's license (no driver's permit) to purchase a parking permit.
5. Permits must be displayed **AT ALL TIMES** on the rearview mirror (printed side showing).
6. Lost/Stolen parking permits will not be automatically replaced. If a permit is lost/stolen, and parking permits are still available for purchase, a student may purchase another parking permit **after a 2 month waiting period.** Students must report the lost/stolen parking permit to the ASB office **immediately** and provide police report for stolen permit. If a valid police report is provided, a temporary permit may be issued. **Initial Here**
7. Students who park in non-student marked spaces will be subject to disciplinary action (may be assigned Saturday school, in-house suspension, loss of parking privileges, or vehicle towed at drivers' expense).
8. Unsafe driving, abuse of privilege or more than two parking violations may result in the loss of your parking permit **without refund.**
9. Parking permits are school documents. Any abuse of a parking permit including, but not limited to, making copies, purchasing for ineligible students, altering or abusing a stolen/lost parking permit may be punishable by suspension. Student's allowing their permit to be copied or allow another student to use will have their permit revoked without refund and may be suspended.
10. If you disenroll at MVHS during the school year, you **must return** your parking permit to the ASB Office. A pro-rated refund may be issued if requested.
11. Students must **maintain a 2.0 Academic GPA** for both semesters of the 2021-2022 school year or parking permit will be revoked.
12. Permits will be available for on the MVHS Web store by Senior and Junior students **ONLY until such time that permits are SOLD OUT.**
13. Parking permits are to be used by the student who purchases the permit only. They are not transferrable to other students for ANY reason.

Parking at Mission Viejo High School is a privilege, **not a right**. Any student parking on campus without a permit will be subject to disciplinary action and/or vehicle can be towed at owner's expense. Please keep in mind the safety of yourself and others when driving and parking on our campus.
