IX.d. District's Independent Citizens' Oversight Committee Thirteenth Annual Report for Measure B - presented by Donald Froelich, COC Chairman and Ernestine Jones, COC Member

Minutes:

Stella Escario-Doiron, Chief of Facilities, Construction and Maintenance introduced Chairman Donald Froelich and Ernestine Jones to present the Thirteenth Annual Report of the Citizens' Oversight Committee (COC). Mr. Froelich explained that it is a requirement of the California State Constitution to present an annual report to the Board. It is remarkable that the District was

able to take the \$180 million bond issue and turn it into an almost \$300 million school improvement program by way of matching funds.

Ernestine Jones explained that the COC committee periodically meets to review the school expense reports, ask questions, and receive status reports. The committee also conducts site visits of school facilities and grounds, as appropriate. Approximately \$10 million was expended on projects during the year including modernization projects for Cielo Vista and Trabuco Mesa Elementary Schools. There were no audit findings during this period. The District was found in compliance with the constitution and followed the applicable terms of the bond measure. The COC will continue the management and oversight of the funds until the bonds and projects are completed. She thanked the Board for their continued support.

Minutes:

Connie Cavanaugh, Assistant Superintendent, Business Services, provided a 2017-18 Second Interim Report. The report included second interim revisions along with reductions implemented in 2017-18. In addition, multi-year projections were presented. SVUSD continues to face declining enrollment and the structural operating deficit is increasing each year. Staff will review and analyze the impact of new legislation and continue to evaluate program needs. The Governor's 2018-19 Proposed Budget Revision will be released in May.
