# IX.d. Measure B and District Facilities Improvement Debt Profile - presented by Connie Cavanaugh, Assistant Superintendent, Business Services and Tim Carty from Piper Jaffray

#### Minutes:

Assistant Superintendent Connie Cavanaugh introduced Tim Carty of Piper Jaffray who presented a report regarding Measure B and an overview of the basics of general obligation bonds. Some of the items included in the summary of the Measure B General Obligation Bond Program were the tax rates, past bond refinancing, amount of state matching funds received, and project accomplishments. An explanation of the professionals and participants involved in a school district bond issuance was provided. from the survey respondents were examined. There is broad support for the current LCAP Goals and Actions/Services. Staff is recommending a wording change to Goals 3 and 4. Moving forward in revising the LCAP, a summary of priorities for LCAP consideration was provided.

### X. COMMENTS FROM VISITORS (on any item NOT on the Agenda)

#### Minutes:

President Swartz provided the following comments:

In order to most accurately provide information for two different topics, I wanted to share the following information that hopefully will clarify any lingering questions. I will provide information in two parts and have separated them as follows: (1) CA Healthy Youth Act, and (2) FAIR Act. These are two very distinctly different laws and are not the same.

### #1 CA Healthy Youth Act

When the State of California voted the California Healthy Youth Act into law in 2016, it required schools to supplement their grade 7-12 health curriculum beginning in January 2017. The State Board of Education has not adopted new Health Standards or approved new health textbooks since 2003, so SVUSD schools continue to use the last state approved textbook at all grade levels.

However, to be compliant with the CA Healthy Youth Act, grades 7-12 periodically use supplemental materials. In SVUSD, our secondary teachers (grades 7-12 only) are able to choose from three supplementary resources: Rights, Respect, Responsibility; Positive Prevention Plus; Be Real, Be Ready. Each intermediate and high school chooses which one (1) supplemental resource to add to their existing curriculum. Supplemental materials in SVUSD are intended and designed to "supplement" the current Board of Education-adopted curriculum. Supplementary curriculum is not material that is Board-approved; it is either created, or selected by content-specific teachers collaboratively for a given subject area and grade level. Several state approved supplementary resources were reviewed by a committee of our health teachers in 2016/2017, and collectively, they selected the three resources listed above. As before, families can "opt out" of curriculum that they do not want their child to participate in through a handwritten note to the teacher.

SVUSD is not selecting, reviewing, adding or adopting any new health material/curriculum until new State Standards and approved materials/texts are identified by the CA State Board of Education. When the state identifies approved health course materials/texts, a SVUSD materials adoption committee will be developed. At that time, there will be an opportunity for parents to review materials under consideration and provide input prior to Board of Education approval.

#### #2 The FAIR Act

The FAIR Act was signed into law in 2011 and mandates that history-social science curriculum includes the "contributions of underrepresented racial, ethnic and cultural

groups. Specifically, these groups include: Native Americans, African Americans, Mexican Americans, Asian Americans, Pacific Islanders, European Americans, lesbian, gay, bisexual, and transgender Americans, persons with disabilities, and members of other ethnic and cultural groups." The FAIR Act recognizes that there are people who have and are still struggling for human rights as part of our California and United States history.

Additionally, the Fair Act requires that instructional materials:

- -Portray accurately and equitably the cultural and racial diversity of American society;
- -Demonstrate the contribution of minority groups and males and females to the development of California and the United States;
- -Emphasize people in varied, positive, and contributing roles; and
- -Not contain inappropriate references to commercial brand names, products, and corporate or company logos.

SVUSD has concluded the process of adopting instructional materials for social science in Tk-12th grade. Our instructional materials adoption process includes teachers and parents evaluating state approved materials in a rigorous process over several months. We recently invited parents to review instructional materials and provide feedback. As part of this process, both parent and teacher committee members learned about the FAIR Act and included this criteria in their materials review.

To be clear, the FAIR Act does not teach about sexual identity or gender topics. Consequently, lessons about morality or sex are not part of the guidelines and are left entirely for parents to discuss with their children at home. The HSS curricula and the Fair Act makes no mention of teaching sexual orientation; it does however identify historical individuals by their gender preferences. Under these updated guidelines, students will learn age-appropriate facts about what really happened in history, but lessons will not include the intimate details of historical figures' lives. However, as students learn history-social science, the contributions of LGBTQ persons as well as persons with disabilities, Native Americans, African Americans, Mexican Americans, Asian Americans, Pacific Islanders, European Americans and members of other cultural and ethnic groups are included in the context of the lesson.

The CA State Board of Education identifies and approves all texts for school district adoption consideration, which they believe includes appropriate grade level content. SVUSD school district personnel, with the Board of Education are obligated to follow the state regulations related to the textbook materials adoption process. The adoption committee diligently reviews each text, weighing the pros and cons, and ultimately reaches consensus. The text selections that are submitted for board adoption do not necessarily represent the views or personal opinions of district staff or the board, but instead represents the collective efforts of a wide-based committee.

In order to be sensitive to our many different community groups, when topics that may prompt additional questions arise, schools will provide advance notice of the topics and when they will be taught in order to give parents time to have conversations with their children in advance- following our interest to support families during these changes in state law.

We hope that this provides additional clarity to these two topics.
