PTA also hosted a Candidates Forum to help voters meet the candidates for the SVUSD Board of Education. prior to the election. The Reflections program was successful and she thanked the Board for their continued support. One SVUSD student received the State PTA Award of Merit. Six of our schools attended the Sacramento Safari which is a PTA advocacy event. Five our schools combined with over 1.000 PTA members in California attended. Two new resolutions were adopted; Early Care and Education for all of California's children and Temperature Control Standards in the School Setting. Resolutions regarding mental health and wellness are being reviewed in order to help educate and advocate for students, parents and teachers in our District. Last week, the last PTA general meeting was held where the new 2019-2020 officers were installed. The 2019-2020 elected and appointed officers were introduced by Ms. Robertson and this year's board were recognized for their service. The SVPTA Historian reported that 27 PTAs and PTSAs in SVUSD contributed 267,285 volunteer hours this year. At the 2019 hourly value of volunteer time. which is \$25.43, this equals a total value of \$6,797,065.18.
