The Mitigation Agreement provides for the potential dedication of a 10-acre site, which if the District is able to acquire, would be used for a new elementary school in the City of Lake Forest. The Mitigation Agreement also provides for alternative mitigation payments to be paid to the District in the event the District is not able to acquire the property for a new elementary school. Minutes:

Trustee Schulman commented that since she has been appointed as the representative to serve on the Coastline ROP Board, she met with Superintendent Carol Hume and two directors and she will be providing Coastline ROP reports at future SVUSD Board Meetings. She went to the PBIS store at Silverado where she was able to see how it works and was amazed to see students using their points to purchase a Christmas present for their parents. Some additional events she attended were the CSEA Holiday party, choir performances at Rancho Santa Margarita Intermediate and Trabuco Hills High School, and Cordillera and Rancho Canada kindergarten performances. Another highlight was the "Les Miserables" performance at Laguna Hills High School. Lastly, she attended a seminar at OCDE on building a stronger united community.

Trustee Kunath commented that he visited Glen Yermo Elementary and learned how hard the principal works with the teachers. In addition, he attended the Laguna Hills State of the City luncheon and he was pleased to see our principals in attendance.

Trustee Swartz commented that she enjoyed going to the PBIS store at Silverado with Trustee Schulman. There is a variety of items to purchase with the points the student has earned. Additionally, she attended the "Les Miserables" play, which was incredible, and a Mission Viejo High School basketball game. She will be attending a Mental Health forum and is happy that Hoag has agreed to partner with our District to assist with our mental health needs. Lastly, she attended the Mental Health Services Act Steering Committee for Orange County meeting. The committee recommends a 3-year plan to the County regarding the funds from the Mental Health Services Act. She continues to advocate for some of the funds to be received by SVUSD to assist with mental health needs.

Trustee Morrell commented that she concurs with the other trustees that "Les Miserables" was one of the best productions she has seen in SVUSD. Some of the other activities and events she attended were the Trabuco Hills High School Jazz Holiday Concert, "Cinderella" production at El Toro High School, and site visit to Foothill Ranch Elementary where she was thankful for the conversations and insight of the teachers. In addition, she enjoyed the ComedySportz challenge between Mission Viejo High School and Trabuco Hills School, and attended the Lake Forest Civic Center Grand Opening.

President Wong commented that he was invited and attended the CSEA Holiday Party which was very well attended. In addition, he attended the Trabuco Hills High School Jazz and Band and Orchestra Concerts. He also agrees that the "Les Miserables" performance was amazing. It was wonderful to attend the Assistance League event at the District office where \$35,000 in grants were given to our teachers. Lastly, he attended the districtwide PTA meeting last night where they offered their support for Measure M.

Superintendent Turner reported that SVUSD started 2020 with many awards. We had a number of teachers and employees nominated for the Parenting OC's Top 25 Employees and five teachers were recognized for the Cox Communication grants. As mentioned earlier, \$35,000 in grants were given to our teachers by the Assistance League. She highlighted that these teachers are already doing fantastic things and taking the time to write grants to get the extra things that they need. She admires their dedication and time they give to our students. She also recognized the important partnerships in our community that help our district thrive including PTA, SVEA, CSEA, SVPSA and local businesses.
