IX.a. Final and 15th Annual Report of the Independent Citizens' Oversight Committee for Measure B

Minutes:

Donald Froelich and Ernestine Jones provided the final and Fifteenth Annual Report of the Citizens' Oversight Committee (COC). This is a milestone in the committee's efforts and the annual report is required by the California State Constitution. One of the key elements of the committee is ensuring that the bond proceeds are used strictly for improvements to the schools. The committee took this responsibility seriously and fulfilled this commitment to the community. With 180 million in bond funding leveraged with state funds, SVUSD was able to complete approximately 325 million in school improvements. During the year, the COC met and received updates regarding project statuses and expenditures as well as attended Ribbon Cutting ceremonies. In addition, the committee reviewed the independent audit, and

SVUSD continues to be in compliance with the California Constitution. There were no audit findings and the report shows that approximately 2.5 million was spent during fiscal year 2019, which completes the construction of Measure B funded projects.

XIV. COMMENTS FROM MEMBERS OF THE BOARD AND SUPERINTENDENT

Minutes:

Trustee Schulman commented that she attended a number of events. Some of these included the Los Alisos play about bullying that was incredible, and the El Toro HS National Letter of Intent Signing which was exciting. She visited Lake Forest Elementary and attended a Conversational Tutorial at El Toro HS where the English Learners and English speaking students come together to have a comfortable place to speak in English and Spanish and learn from each other. She attended a Socratic Seminar given by 4th graders and the student recognition for Mission Viejo students by the Kiwanis. She toured Rancho Canada Elementary and attended ComedySportz at Laguna Hills HS. She commended SVUSD teachers who go out of their way to provide extra experiences to our students to enrich their learning.

Trustee Kunath commented that he is impressed with the Wellness Wednesday Program that was presented during the meeting and feels other schools would benefit from a similar program. He looks forward to visiting school sites and the Government Leaders Prayer Breakfast in March.

Trustee Swartz commented that she attended the Opening Ceremonies for the Model United Nations event at Mission Viejo HS and their National Letter of Intent Signing where nineteen athletes signed. Mission Viejo HS had twelve football players signing letters which is more than any other high school in Orange County. She joined Superintendent Turner and staff at the County Mental Health Forum. It was apparent that we need to educate the County about our needs, which include dedicated staff to address mental health needs. In addition, she attended the budget seminar regarding the governor's budget and two County Committee on School District Organization meetings. One of the meetings was held at SVUSD where the SVUSD Trustee Area Map was approved. Next week, she will be visiting Del Cerro Elementary.

Trustee Morrell commented that she is impressed every year with the Model United Nations event. It is student run and hosts students from various schools. They are learning lifelong skills in communicating and debating issues. She complimented Chris Hixson who had intermediate drama students at Los Alisos take on and execute the topic of bullying in a mature fashion.

President Wong commented that this was the first time he had seen intermediate students participate in the Model United Nations program at Mission Viejo HS. He also attended the Southern California Honor Band and Orchestra Assembly where three students from Rancho Santa Margarita Intermediate participated and did a great job. He attended the Orange County Budget meeting and congratulated Student Board Member Sam Tullis for the complimentary article in the newspaper about him being the founder of the Laguna Hills HS Chapter of TILE Talks. He visited Gates Elementary and attended the Laguna Hills HS vs San Juan Hills and Mission Viejo HS vs Aliso Niguel basketball games. He enjoyed the Principal for a Day luncheon and Mission Viejo HS National Letter of Intent Signing. In addition, he joined Superintendent Turner and staff to visit the three teachers and one staff member who were among the teachers and staff chosen as Parenting OC's Top 25 Teachers and Employees. He attended the Orange County School Boards Association dinner meeting and thanked Trustee Swartz for her continued efforts in advocating for SVUSD's mental health needs.

Superintendent Turner shared that during the Principal for a Day luncheon, guest principals are given an opportunity to comment about their day. Every comment included how impressed they were with our innovation, the flexible furniture and how student learning has changed over the years. She emphasized that Measure B helped with the current improvements and innovation. Our audits have repeatedly demonstrated that our budgets are fiscally responsible and smart which led to almost doubling the money that the voters put forward with Measure B. It is important to remind everyone that SVUSD has a long history of good financial decisions.
