IX.a. Coastline Regional Occupational Program (CROP) Report - presented by Barbara Schulman

Minutes:

Trustee Schulman provided a Coastline ROP report. In Sacramento, Superintendent Hume met with Assembly Member Quirk Silva and others to discuss how important business partners are in the program. They discussed 2 bills:

- -AB 2682 which is proposing permanency for ROP teachers. The discussion of how important it is to have flexibility in program offerings was discussed. Jobs for the future change, so courses must be able to also.
- -AB 2502 is similar to a bill that died last year about consolidating and streamlining two funding sources for CTE and K12 Strong Workforce Programs.

K12 Strong Workforce awarded \$900,000 for round two of this funding in the consortium. The funding will be used for building a skilled workforce through work-based learning.

Congratulations to:

- -Patrick Sullivan's advanced auto students at Laguna Hills High School who won first and fifth place on March 5 at the Cypress College Automotive Competition. Santiago Guerrero and Luis Contreras won first place. Yader Rivera and Chris Corona won fifth place.
- -Dan Shell, Foods Cooperative teacher at El Toro High School for his recent recognition in Parent OC Magazine as being a top educator. The article referenced his teaching CTE.

The Newport Harbor High School culinary arts program was featured in the presentation. The students discussed the variety of programs they have at the school and the many competitions they are in.

IX.b. Local Control and Accountability Plan - presented by Liza Zielasko, Assistant Superintendent, Educational Services

Minutes:

Assistant Superintendent Liza Zielasko provided a Local Control and Accountability Plan (LCAP) report. The revision process, timeline and the data that will be used to revise the LCAP were provided. The LCAP is a 3-year inclusive plan. The LCAP's greatest areas of progress and needs were reviewed. The annual review includes a survey and the comments from the survey respondents were examined. Various stakeholder meetings were held to review the data and provide feedback. The new template and guidance from the State and County requires using broad goals with more specific actions and services. The intention of new template is to be more transparent to the public on what the goals are and why they are important. The draft of proposed broad goals based on the eight state priorities were reviewed. A summary of priorities that emerged from the various stakeholders was presented, which included further implementation of MTSS, continue to offer high quality and a variety of professional development, and support technology in the classroom with professional development.
