IX. PRESENTATIONS

IX.a. La Paz Intermediate School, Recipient of Golden Bell Award: First 20 Days - Supporting Student Success Program - presented by Liza Zielasko, Assistant Superintendent, Educational Services

Minutes:

Liza Zielasko, Assistant Superintendent, Educational Services, introduced Principal Jean Walker and shared that La Paz Intermediate School was selected to receive the prestigious California School Boards Association (CSBA) Golden Bell award for closing the opportunity gap through LCAP implementation. SVUSD and La Paz Intermediate School were honored for their "First 20 Days Supporting – Students Program" at a pre-recorded CSBA ceremony held virtually in December. President Swartz congratulated Principal Walker and presented her with the Golden Bell Award.

X.a. PTA Council Report - presented by Michele Sparks, SVPTA President

Minutes:

Michele Sparks, SVPTA President, provided a report. After spending the first part of the year primarily supporting the school sights, SVPTA will continue a higher level of advocacy for mental health support and resources for SVUSD students. The initial stages of planning are underway for education nights for parents. Topics will include Canvas and Google training, suicide awareness and prevention, coping strategies for students during COVID, resources, and navigating special education. Michele and SVPTA's Advocacy's representative, Keri Baert, will be meeting with Senator Min. Senator Min is interested in their perspective of the current climate in schools and impact of COVID-19. PTAs continue to spread messages of hope and positivity, and provide resources and ways for family engagement. She encouraged members of the community to join PTA.

X.b. Saddleback Valley Educators Association Report - presented by Joyanne Goodfellow, SVEA President

Minutes:

Joyanne Goodfellow, SVEA President, provided a report. She reported that many teachers have contracted COVID-19 and asked that SVUSD look into COVID-19 testing and leave options. Teachers worked through some technical issues with Canvas and PowerSchool at the start of the semester. The SVUSD Showcases will look different this year. Virtual tours are being recorded and teachers are creating various products to provide the best overview possible. Itinerant elementary music and PE teachers have been reassigned to the secondary schools. This is one of the effects of COVID-19 that has impacted the education for the elementary students. She looks

forward to seeing how Orange County plans to distribute the vaccine.

X.d. Facilities Master Plan Update - presented by Robert Craven, Assistant Superintendent, Facilities, Operations and Technology; and Stella Escario-Doiron, Chief of Facilities, Maintenance, Operations, Construction, and Transportation

Minutes:

Assistant Superintendent Robert Craven and Chief of Facilities, Maintenance, Operations, Construction and Transportation Stella Escario-Doiron provided a Facilities Master Plan (FMP) update. An overview of the FMP adopted in August 2019 was provided which included \$563 million in facilities needs over ten years. Measure M was not successful and immediately after, COVID-19 shifted the focus to safety.

The FMP has been impacted by both of these situations. The modernization dates for SVUSD schools was provided, which illustrated that many of the elementary schools were modernized 15-20 years ago. The current funding sources and priority projects were reviewed along with current 2021 funded projects along with the unfunded priority projects for 2020-2022. Staff recommends moving forward with projects that address infrastructure and health and safety needs.

Projections of facilities use which is determined by student enrollment was reviewed. Current developments in the District boundaries and elementary school enrollment projections through 2029 for schools that are projected to be under 400 students were provided. For these schools, current enrollment, projected enrollment in 2025 and 2029 was shown. A minimum student enrollment of 450-550 is needed for instructional and operational sufficiency.

The long term facilities needs were reviewed including a long-term location for the Virtual Academy, increased outdoor space at Silverado, additional space for professional development and sufficient elementary student enrollment. SVUSD will continue to look at District leased property and evaluate whether to continue to lease or sell the property. The District will establish a Facilities Focus Group to review elementary schools with projected enrollment under 400 students and provide solutions for operational and instructional issues to present to the Board for consideration.

XVI. COMMENTS FROM MEMBERS OF THE BOARD AND SUPERINTENDENT

Minutes:

Superintendent Turner commented that as a follow-up to the Board comments from last month's meeting, a letter has been sent to the State Board of Education, Governor Newsom, and State Superintendent, outlining our concerns and that we do not agree with state testing should be done this year. The Orange County Superintendents group has also sent a letter and she encouraged PTA and SVEA to join the effort.

Trustee Schulman wished everyone a happy New Year. She thanked teachers, all staff, parents, and students for everything they do every day. She enjoyed listening to Dr. Boaler on staff development day and thought her presentation was interesting.

It was wonderful to learn that Los Alisos Intermediate is going to start clubs virtually. She thanked the Board for all of the good conversations they have.

Trustee Kunath commented that he is optimistic for 2021. He plans to be more active on the Board and with special interests including the PTA.
