X.a. District English Learner Advisory Committee (DELAC) Report - presented by Rowena Mak, Coordinator, Services for English Learners, and Ingrid Anderson, District Community Liaison

X.c. Mission Viejo New Development Elementary Boundary Adjustment Area 854b - presented by Robert Craven, Assistant Superintendent, Facilities, Operations, & Technology

Assistant Superintendent Robert Craven provided a report regarding the boundary assignment of a new development in Mission Viejo. The new development is located in a previous commercial area and in attendance area 854, which is assigned to Melinda Heights Elementary School. SVUSD staff recommends creating attendance area 854b for the new development which would be assigned to Del Lago Elementary School. Enrollment projections with and without the new boundary assignment were reviewed.
