VIII. PRESENTATIONS/RECOGNITIONS

VIII.a. 2021 California Positive Behavioral Intervention and Supports (PBIS) Coalition Recognition

Minutes:

Liza Zielasko, Assistant Superintendent, Educational Services introduced Kathy Stauffer, Teacher on Special Assignment, who has been working on SVUSD's Multi-Tiered System of Supports in the area of Positive Behavior Intervention and Supports (PBIS). Ms. Stauffer explained that PBIS is an evidenced based proactive approach to teaching and reinforcing positive behavior in students. With over 30 years of research, PBIS is implemented in all 50 states and over 20 countries around the world. The California PBIS Coalition established rigorous standards to school sites to achieve State recognition for their implemented practices. The following SVUSD schools were recognized:

Silver Level: Del Cerro Elementary, Lake Forest Elementary, Rancho Santa Margarita Intermediate, San Joaquin Elementary, and Silverado

Gold Level: Melinda Heights Elementary

Platinum Level: Los Alisos Intermediate

Board President Suzie Swartz congratulated the schools and presented certificates of recognition on behalf of the Board.

IX.a. Coastline Regional Occupational Program (ROP) Report - presented by Barbara Schulman, Coastline ROP Representative

Minutes:

Trustee Schulman provided a Coastline ROP Report. Trustee Schulman emphasized the importance of ROP. Patrick Sullivan, from Laguna Hills High School, received the Teacher of the Year award. Ten new teachers were added in various districts. It was reported that next year, the K-12 Strong

Workforce Program may allow two applications. Currently, only one application is permitted and only three districts can be on the application. ROP works with five districts, so the additional application would be extremely beneficial. The Career Technical Education Incentive Grant approval by the State Board of Education was postponed until January. There is new language included for an additional \$150 million which will guarantee that IB, Dual Enrollment, and AP will also be brought into ROP. Superintendent Hume is retiring effective February 1, 2022, and Leadership Associates has been chosen as the search firm to facilitate the selection of a new superintendent.

IX.b. PTA Council Report - presented by Michele Sparks, SVPTA President

Minutes:

Michele Sparks, SVPTA President, provided a report. She reported that PTAs continue to find ways to create normalcy, boost morale, and engage families. Some of the activities include fundraisers, helping to fund playground supervisors, virtual events, appreciation breakfast for staff and faculty, Frozen Treat Friday and gift bags for students. PTA continues to support the community and provide resources, as well as advocate for mental health.

Certificated substitute recruitment efforts were reviewed, and the District is continuing to find creative ways to fill vacancies and address substitute shortages.
