# a. Student Board Member and High School Representatives Report

Student Board Member Kaitlyn Heinecke and the High School Representatives reported on the activities of their adopted and home schools.

# b. Coastline Regional Occupational Program (ROP) Report - presented by Suzie R. Swartz, Coastline ROP Representative

Trustee Swartz provided a Coastline ROP report. Mike Gentile, the founder and director of Cyber Forward, and some SVUSD students made a presentation on the Cyber Forward class. Cyber Forward provides students with the training necessary to work in cyber security and the link to businesses to job shadow and also intern to get real world experience. The class is virtual and currently offered in the summer. Today was the first time that a SVUSD Trabuco Hills High School student, a Corona Del Mar student and a University High student actually met in person after spending the summer together in the virtual class. In addition to gaining technical skills, students also learn vital communication skills. They learn to develop and make presentations where they must effectively communicate technical information to non-technical people. There are some Cyber Forward graduates working part time in paid internships while they pursue higher education. It is hopeful that CROP will be able to offer this class starting this spring as well as over the summer.

Superintendent Dozer reported that the webinar to help students leverage their CTE/ROP experience to differentiate themselves on college applications was a huge success with over 100 students participating.

# c. PTA Council Report - presented by Vanessa Tingey, SVPTA President

Vanessa Tingey, SVPTA President, provided a report. She appreciates the high school representatives for highlighting some of the wonderful activities at the school sites. It is also great to see parents on campus again, which supports community building. A key focus of SVPTA is their partnership with SVUSD and SPED families. Monthly support groups have begun where resources can be shared. SVPTA is encouraging parents to attend Sacramento Safari and looks forward to working with the district on supporting SPED and inclusion.

# d. Saddleback Valley Educators Association Report - presented by Joyanne Goodfellow, SVEA President

Joyanne Goodfellow, SVEA President, provided a report. She commented that it is the last day of finals for intermediate schools. The timeline for Teacher of the Year has been moved up to align with OCDE. There are some concerns regarding support for SPED and some aging infrastructure. She thanked the Board for having a Special Board Meeting to approve the SVEA contract.

# e. Safety Report Presentation - presented by Robert Craven, Assistant Superintendent, Business Services and Henrie Watkins, Safety Consultant with Specialized Safety Services

Robert Craven reviewed the areas of focus regarding safety from 2018 through 2022, and stated that work is ongoing in these areas. This report provides initial findings from the recent safety assessment completed by Specialized Safety Services. The scope of the assessment was reviewed, which included a complete hazard and vulnerability assessment at every school, a report with recommendations at the District level, actionable guidance, and suggested focus areas for the Safety Committee work between 2023-2026. Mr. Craven introduced the safety consultant, Henrie Watkins, who provided a summary of the assessment. He visited each school site and reviewed their processes. A complete hazard and vulnerability assessment was completed at every school. Mr. Watkins explained the definition of hazards as it relates to the scope of the assessment. In addition, the tools used in completing the report were explained. As a result of the assessment, he provided four recommendations for the District to consider.
