b. Coastline Regional Occupational Program (ROP) Report - presented by Suzie R. Swartz, Coastline ROP Representative

Trustee Swartz provided a Coastline ROP report. Coastline ROP will be offering the Cyber Security Training 2.0 Internship Class for high school credit this Spring semester. The class is virtual. Three Zoom information sessions will be offered for interested students to learn more. The information has been sent to all SVUSD high school assistant principals and guidance staff. The application deadline is January 18.

e. First Interim Financial Report - presented by Robert Craven, Assistant Superintendent, Business Services

Robert Craven, Assistant Superintendent, Business Services, provided a 2022-2023 First Interim Budget Report. The major assumptions used when developing the report were reviewed. Changes in the unrestricted budget were explained. There is an increase in revenue and expenditures, which resulted in an increase in the unappropriated balance. The multi-year projection was presented along with an overview of the assumptions used. The spending commitments and assignments the Board previously approved were reviewed in addition to the proposed commitments. The proposed commitments include safety projects and continuation of the SV Innovates Classroom project. Enrollment continues to decline, and the STRS and PERS rates are stabilizing, but the District's overall contribution increases. The Governor's proposed budget for 2023-2024 will be released in January. The Second Interim Budget will be presented in March.
