Student Board Member Kaitlyn Heinecke and the student representatives reported on the activities of their home and adopted schools.

b. Coastline Regional Occupational Program (ROP) Report - presented by Suzie R. Swartz, Coastline ROP Representative

Trustee Wong provided the Coastline ROP report in Trustee Swartz's absence.

The CROP Board met on August 18th. Over the summer, CROP offered:

- Emergency Medical Responder
- CyberForward
- Careers in Artificial Intelligence
- Medical Innovation, Research, and Entrepreneurship (MIRE)
- Professional Interns

Superintendent Brian Dozer reported that the interest level in these summer courses was very, very high and they will be looking to find additional opportunities with industry for the students. He also reported that AB 2573 (McCarty), which CROP opposed since it would have allowed ROP instructors to attain permanent status, was held in the Senate Appropriations Committee and barring any rule waivers, AB 2573 is dead for the year. In addition, he reported that staff worked this summer on the K16 Collaborative Grant initiative and, with the input of their districts, submitted for funding for two potential pathway projects in Supply Chain Management and Entrepreneurship. Staff have been working on a plan to offer adult CTE fee-based classes again, to increase revenue. CROP expects to re-start in December 2022 with CPR classes and is also looking at Dental and CNA classes for the winter/spring of 2023.

Sesar Morfin, Director of Business Services, presented the Quarterly Report of District Investment Performance and Annual Policy Review.

JS Coke, Director of Instruction Services, introduced CROP's new Work-Based Learning / Outreach Specialist, Mr. Hasan Asrar. Hasan's role is to initiate and deepen connections with business and industry to support work-based learning activities for students and to broaden the work and influence of the ROP.
