X.a. PTA Council Report

Minutes:

Robert Craven read the following report from Michele Sparks, SVPTA President.

Good evening Superintendent Turner, President Wong, Board members, staff, parents, students and guests.

As you can imagine, planning for PTA is more challenging this year, as are most things during COVID. I want to thank all the Presidents, their boards & volunteers that have come together & are finding ways to support their schools.

We are finding new ways to engage our communities & support our families. Our Presidents are communicating regularly with their schools to determine the best way to support their teachers, students, school sites & administrators during COVID. We are helping communicate important information to parents from SVUSD. We are advocating & communicating information regarding key issues that can help our students during the Pandemic. Key focal areas this year will include social emotional resources/support for students, the importance of art academically & as a coping mechanism for social/emotional

health, special education resources, inclusivity, online safety for children, vaping legislation & so much more!!!

I'm so proud of how creatively our local PTA's have supported our teachers, students & families. They have posted on school fences, banners of positivity to "STAY STRONG, WE ARE ALL IN THIS TOGETHER", they've hosted virtual bingo nights, not so social ice cream socials, and mindfulness messaging through social media. Our local PTA's have been a conduit of communication for SVUSD regarding COVID updates & sharing accurate information regarding both distance learning & return to school messaging. Our PTA's have created SURVIVAL kits for teachers with essentials to get them through their long virtual days. As the year continues we will provide additional support such as school supplies for students & teachers, arts awareness & resources, social/emotional support & resources for both students & families, and much more.

I want to reiterate that our GOAL this year is to support our community based on the current needs of our students, teachers & school sites. We realize these needs are different this year. We will be surveying our communities to determine & help provide what is needed. An important reminder is that our SVPTA community is defined as our students, teachers, staff, administrators & families!!! "We are truly stronger together"

With Distance Learning, many have asked, WHY join PTA? In addition to supporting our schools locally in the previously mentioned ways, PTA advocates for much bigger issues facing our youth. We are the largest children's advocacy group in the United States.

On August 28th, Governor Newsom signed SB 793 into law which starting January 1, 2021, will make selling flavored tobacco products, including vaping products, in the state of California illegal. Our SVPTA and other local PTAs advocated for the passing of this law at our Fourth District's Sacramento Safari in late February.

California PTA also actively supported this bill after a resolution on this matter was adopted this summer at our statewide association meeting. PTA members were encouraged to reach out to their legislative representatives to ask them to vote yes on this bill. SVPTA is happy that this bill passed and is proud to be working towards solutions to help solve the youth vaping crisis.

On the Arts front, I want you to picture little Johnny sitting at his desk Zooming with his teacher. It's been 2 hours since school started and he has begun to lose interest. During break, he ransacks the fridge and goes to the bathroom. Once recharged, he's back at his desk and ready for another couple hours of instruction but again gets distracted. This is the typical day of our SVUSD students while they distance learn. How do teachers know they're reaching the students? A great solution for both teacher and student is to add arts integration! Reading an essay? Request to do it in an accent. Graphing a geometric shape? Add a nose and eyes. Share your new cartoon character

with the class. There are so many ways that teachers and students can end the monotony without taking away from their academic schedule. Inserting one of our 5 art disciplines (visual arts, performing arts, dance, music, or mixed media) will help solidify the lesson AND refocuses a student's attention towards the subject. When exercising this part of the brain, it strengthens their mind-muscle and serves for better critical thinking as the student progresses through school. Art is a core subject, not an option! Let's help our students with all the skills in the toolbox - art being the hammer that aids all other subjects. Stay tuned for our Arts Advocacy comments to find out what Johnny learned today.

Good Evening President Wong, Vice President Morrell, Trustee Swartz, Trustee Schulman, Trustee Kunath & Dr. Turner:

SVEA leadership has recently changed. Due to COVID and all the challenges everyone faced in the Spring, SVEA held their elections in August. My name is Joyanne Goodfellow and I was elected as SVEA president. We have several new members of our executive board as well. We are all excited, and a little nervous, to help lead our members and work with the district on all issues.

COVID has changed the face of education across the world. Everybody has an opinion and everybody has their own concerns. When we look at returning to in person instruction, we need to be aware of the health and wellness of our students and all of our staff. The numbers across America show with schools opening, the positive cases are going up, not down. I urge you, on behalf of the teachers and our students to consider not rushing to return to school. Secondary teachers seeing their students in person once a week is not going to significantly increase their learning. Elementary teachers will see students every day, but the program will not be the same with masks and physical distancing in place. Being on campus does not equal a better education.

Please, think about what is the best learning for students as well as the best health of all.

Our teachers are working upwards of ten hours a day and many of us are working on weekends to ensure our students are getting the education they deserve. Teachers are learning new curriculum, new grade levels and trying to handle combo classes through distance learning. The district keeps adding more to the teachers' plates, without remembering that we had our plates filled just by distance learning. The hybrid model explained to me at my site is just distance learning in a classroom. SVEA teachers are giving you 150%; please remember that when you are discussing the next responsibility to add to our professional obligations.

I look forward to continuing to work with the district and the board on behalf of SVEA teachers. As I said in my campaign, we can do more, together. And we are in this together.

X.d. Update on Re-opening of Schools

Minutes:

Superintendent Turner provided an introduction regarding the possible reopening of schools based on the current State and County guidelines. She introduced Liza Zielasko who provided a presentation along with James Newton. Connie Cavanaugh, and Robert Craven on the reopening of SVUSD schools using the hybrid instruction model. Sample schedules at the elementary and secondary level were provided. Safety measures that will be implemented were reviewed. Campus site walks have been conducted to check the preparation of school sites to ensure that health and safety measures are in place. An extensive safety checklist was used to confirm that all classrooms and workspaces are ready for in-person learning. The process and actions that will be taken if someone tests positive for COVID-19 were explained. This includes the District's coordination with the Orange County Health Care Agency and necessary notification and communication. Health and safety is a top priority and a Memorandum of Understanding was created in collaboration with SVUSD employee groups to address COVID-19 related impacts. Human Resources is supporting employees by providing COVID-19 information, leave options, and medical accommodations, if needed. Multiple opportunities for training for certificated and classified substitutes has been provided. Once a return date for in-person learning has been established, substitutes will be pre-scheduled to cover last minute absences.
