IX. REPORTS

IX.a. Coastline Regional Occupational Program (CROP) Report - presented by Amanda Morrell, CROP Representative

Minutes:

Trustee Morrell reported that the Coastline ROP Board met on Thursday, June 15. They approved the interagency agreement for ROP services with SVUSD as well as the 2017-18 budget. The funding levels remain unchanged from 2016-17.

Trustee Morrell provided clarification in order to make sure that everyone is aware that under the LCFF, SVUSD ROP funds are included in the SVUSD base funding. Although it is expected that districts will receive the same level of ROP funding going forward, it is no longer a separate line item in the State's budget; therefore, it is not separated on a district's allocation. The Governor's May revised budget proposal for 2017-18 continues to include ROP funds as part of a district's base grant, but ROP's funding is dependent on the continuing participation of the partnering districts and effective future increases in funding to cover the increased cost of services and/or additional services such as new program offerings. Those items will need to be negotiated with partnering districts on an individual basis. Coastline ROP is continuing to work with the other JPA ROPs and School Services to secure ongoing funding for CTE and ROPs.

There are some organizational changes to report. Anna MacDonald resigned in April. After much thought and consideration Coastline ROP has decided to eliminate the position of Manager of Student Services and expand J.S. Coke's responsibilities to include Student Services. He will become the Director of Educational Services. The three instructional program coordinators will be administrators of Educational Services and will align the administrators' assignments by district(s) instead of programs. While the program alignment model has served ROP well, it is believed that the level of service to each district will be strengthened by having one point of contact for instructional support. The administrators will assume responsibility for the career specialists assigned to each district. At SVUSD, we will have our own administrator because of the number of offerings, while the other districts will share one amongst two districts. The intent is to create a more cohesive team and it also helped to reduce some costs.

Nasario Solis, who teaches Administration of Justice and Crime Scene Investigation in SVUSD, was announced teacher of the year by Coastline ROP.

Laguna Hills High School received an award for "Excellence in Storytelling" for their short film "The Color of Life" at Zipper Concert Hall in Los Angeles. The festival showcased dozens of winners from all over the state for the 51st Annual California Student Media Festival sponsored by PBS SoCal and Discovery Education, among others.
